Training and Professional Development - Provided a total of 43 training, consultation and professional network opportunities statewide and hosted one statewide learning & leadership summit serving over 1,840 professionals and individuals. Training includes online, self-guided tools with built-in knowledge assessments, pre-service program training, parent support and leadership development, ongoing child maltreatment prevention webinars, fatherhood engagement, and Motivational Interviewing.

Public Education - Statewide public information and community awareness campaigns are designed to help individuals and communities understand the short and long-term impact of child maltreatment, as well as to inform the public about the importance of healthy childhood growth and development. Toolkits, parenting brochures, statistics and research, and skill building tips are provided to all 100 communities and over 12,000 organizations and individuals across the state with 80% of communities reporting active participation in awareness activities. Information is provided to all interested citizens in regards to accessing parenting support in local communities, a toll free phone line for information and referral services, and how to recognize and respond to child maltreatment.
