Public Education - Statewide public information and community awareness campaigns are designed to help individuals and communities understand the short- and long-term impact of child abuse and neglect, as well as to inform the public about the importance of healthy childhood growth and development. Toolkits, parenting brochures, statistics and research, and skill building tips are provided to all 100 counties and over 12,500 organizations and individuals across the state with 87% of communities reporting active participation in awareness activities. Information is provided to all interested citizens in regards to accessing parenting support in local communities, 800-line for information and referral services, and web-based training on how to recognize and respond to child maltreatment.

Training and Professional Development - Provided a total of 16 training, consultation and professional network opportunities statewide and hosted one statewide learning & leadership summit serving over 2,179 professionals and individuals.
